<u>Nomination for election of Management Committees –</u> <u>Deputy Chair for Years 2024 & 2025</u>

The roles and duties of above-mentioned post shall be referred to the *Appendix 2*. In accordance with paragraph A.1. of the *Appendix 1 - Nomination Procedures and Details*, each nomination must be proposed by a FCIPHE and supported by two ACIPHE or above current members, where each current member could propose or support one nomination only.

Each nomination shall be sent by post AND email to the CIPHE-HKB by completing the Nomination Form for election of Management Committees – Deputy Chair for Years 2024 & 2025 (*See Appendix 3*). Candidate shall only choose one vacancy post and the current stepped down Branch Committee members shall be entitled to stand for re-election. Candidate shall also submit the following supplementary information on a single sided A4 paper (*See Appendix 4*) and Register of Interest (*See Appendix 5*) for circulation to Executive Committees for consideration:

- Personal information
- Present position or occupation and brief work history
- Membership and offices (present and/or former) held in the Institution
- A brief supporting statement

All candidates are invited to prepare the election material after they have submitted their Nomination Form and the Nomination was confirmed to be valid by CIPHE-HKB.

Appendix 1: Nomination procedures and details

- A. Procedures for Nomination of Management Committees Deputy Chair:
 - 1. One Incumbent CIPHE-HKB Committee member (Year 2020 to 2023), One FCIPHE and One ACIPHE or above current valid full paid members may submit to the CIPHE-HKB in writing a nomination on the prescribed form by the closing date of any other person duly qualified to fill a vacancy for Management Committees Deputy Chair.
 - 2. No candidates shall be allowed to withdraw from the election after the close of the nomination period.
 - 3. Candidates, Proposers and Supporters must be valid full paid members of the Institution.
 - 4. Each member can nominate/ propose/ support at most one candidate. If nominated repeatedly, all related nominations will be considered as invalid without further notification.
- B. Guidelines for Election of Management Committees Deputy Chair:
 - 1. If the following situation occurs, the nomination will be considered as invalid:
 - (i) The candidate is serving as Committee/ Director/ Executives for other Institutions/ Societies/ Professional Body related to plumbing and drainage discipline and there is chance of conflict of interest.
 - (ii) The candidate is considered to violate Code of Professional Standards by CIPHE.
 - 2. The nomination period begins on the day the election and nomination notice is issued, and lasts for nearly one month.
 - 3. Candidates can only select one out of six vacancy posts e.g. Deputy Chair-Technical, Deputy Chair-Social, Deputy Chair-Membership, Deputy Chair-Newsletter, Deputy Chair-Liaison, Deputy Chair-Young Member.
 - 4. Candidates selecting Deputy Chair Young Member must be current valid Young Members Committee (YMC) Sub-Group member and aged under 40.
 - 5. The nomination form must be verified by the CIPHE-HKB before candidates can become official candidates.
 - 6. Eligible candidates will be informed within one week after the deadline/ close for nomination.
 - 7. If there is only one eligible candidate, that candidate will automatically be elected as the corresponding Deputy Chair and no voting is required.
 - 8. If there are two or more candidates, the election procedure will be kick started.
 - 9. Candidates must ensure their submitted election materials are correct and free from misrepresentation. Any mistakes made in their election material may be deemed evidence of misconduct and could be subject to strict disciplinary action.
 - 10. If the election material or the photograph is not submitted in time, the same will not be included in the list of Candidates circulated by the Institution. The Institution has the authority to delete any passages that are deemed defamatory and unsuitable.
 - 11. Voting will be conducted on the basis of one person, one vote, and the person with the most votes will be elected; if the candidates get the same votes, it will be decided by draw lots.
